**TERMS OF AGREEMENT**

**The Waterford Speedbowl herein refers to the Waterford Speedbowl, it's employees, and any person or entity associated with it.**

**CONTRACT:** I am an independent contractor assuming all responsibility for money received as a result of my activities, including, but not limited to income tax , FICA, Workmen's Compensation, and withholding taxes. I am not an employee or agent of The Waterford Speedbowl.

**BENEFITS:** I agree that myself, heirs and assigns will be entitled only to the benefits of the Competitor Accident Policy procured by The Waterford Speedbowl for accidental injuries or death, which are the result of external, violent, and visible means sustained in The Waterford Speedbowl Motorsports and Entertainment activities. The foregoing shall constitute the limit of liability of The Waterford Speedbowl for such injuries occurring to me in any Waterford Speedbowl event: I unconditionally release and indemnify The Waterford Speedbowl regardless of the cause and nature of the injury or death.

**COMPLIANCE:** The undersigned agrees to abide by all rules and regulations of The Waterford Speedbowl and/or NASCAR, and/or INEX now or herein after promulgated. In consideration of the acceptance by The Waterford Speedbowl of this agreement, the undersigned recognizes his obligation to the public and to The Waterford Speedbowl, which posts the prize money and conducts the event, and agrees to compete in all events when qualified if humanly possible.

**BREACH and DAMAGE:** In the event the undersigned breaches this agreement, he shall be liable for actual and liquidated damages sustained by The Waterford Speedbowl.

**ADVERTISING RELEASES:** The undersigned consents to the use of his name, picture of himself and his car for publicity, advertising and endorsements both before and after the events, and relinquishes any rights to photos taken in connection with events and consents to the publication or sale of such photos as The Waterford Speedbowl desires.

**ARBITRATION:** Any controversy or claim arising out of or relating to this agreement, including any alleged breach, shall be settled in accordance with the rules of The Waterford Speedbowl and/or NASCAR, and/or INEX. The undersigned agrees to accept the decision as final without appeal.

Additionally, I agree that I am bound by the following:

The rules and/or regulations set forth by The Waterford Speedbowl, track management and/or race officials are designed to provide for the orderly conduct of racing events and to establish minimum acceptable requirements for such events. These rules shall govern the condition of all events, and by participating in these events, all participants are deemed to have complied with these rules. NO EXPRESS OR IMPLIED WARRANTY OF SAFETY SHALL RESULT FROM PUBLICATIONS OF OR COMPLIANCE WITH THESE RULES AND/OR REGULATIONS. They are intended as a guide for the conduct of the sport and are in no way a guarantee against injury or death to a participant, spectator, or official. The Competition Director and/or Management shall be empowered to permit minor deviation of any of the specifications herein or impose any further restrictions that in his/their opinion do not alter the minimum acceptable requirements. NO EXPRESSED OR IMPLIED WARRANTY OF SAFETY SHALL RESULT FROM SUCH ALTERATION OF SPECIFICATIONS. Any interpretation or deviation of these rules is left to the discretion of track management. Their decision is final, non-appealable, and non-litigible.
