CAR NUMBER RENEWALS:

The deadline for the reserved renewal of your 2008 season car number is **January 31, 2009**. If your registration form and \$30 fee are not at the Waterford Speedbowl office by 1/31/09, your number will no longer be reserved for you and will become available for claim.

Confirmation of your 2009 car number will be mailed or e-mailed to you.

Notice: If you purchased a car number in 2008, but did not attempt to qualify a car with that number, you do NOT have the renewal rights to that car number.
